
To pay the fees online the students have to go to the NIPER website ([www.niper.gov.in](http://www.niper.gov.in)) and click on "Online fee payment link". After clicking this link the SBI online portal will appear.

On appearance of SBI portal window, the student has to accept <Terms Conditions>, and then select <Proceed>. A new drop down menu will appear where the student will select state<Punjab> and then select Corporate/Institution Type <Educational Institutions>. Another drop down menu will appear where the student has to select <NIPER Fee A/c>. On appearance of another menu the student will select from <Payment Category> and enter his/her Registration No. The students need to enter his/her Registration No. in Capital letters only without any space between numerals and alphabets e.g 10RTM1111. The remaining process is self explanatory. Process of online fee payment is also elaborated step by step in instructions of payment of fee link available on NIPER website.

After 21<sup>st</sup> June, 2020 a new window for payment of late fee will also appear. All students who will pay their fee with late fee are required to submit the fee along with late fee.

After the payment of fee online, the students are required to register themselves. For this, soft copy of the registration form is available on NIPER website. Students may download copy of the Registration Form from there and submit the form duly filled in within the prescribed dates in the department itself. The concerned department shall send the same to the Academic and examination Section along with the online fee receipt/ photocopy of the fee receipt. Non-submission of fee shall attract late fee/ fine or cancellation of registration.
