Applications are invited from eligible Indian nationals for a post of **Senior Research Fellow** under a project entitled “Implication of epigenetic modulators and adiponectin mimetics in the reprogramming of circadian genes responsible for the pathogenesis of Poly Cystic Ovary Syndrome (PCOS): A novel therapeutic approach in the treatment of (PCOS)” sponsored by Indian Council of Medical Research (ICMR), GoI, New Delhi [GP-453] under Dr. Kulbhushan Tikoo, Professor and Head, Department of Pharmacology and Toxicology. The position is purely temporary, initially for **1 Year**, extendable up to **Two years** based on the performance of the candidate and is co-terminus with the duration of the project.
