1.0 NOTICE INVITING APPLICATION FOR EMPANELMENT

National Institute of Pharmaceutical Education and Research is an autonomous Institute working under the purview of Department of Pharmaceuticals, Govt. of India, situated at Sector-67, S.A.S NAGAR.

The Director, National Institute of Pharmaceutical Education and Research, Sector-67, S.A.S NAGAR invites applications for empanelment of contractors from the firms who are registered with CPWD/State PWD/MES/Railways/MSEDCL, Semi Govt. 1.2 ELIGIBILITY CRITERIA:

Prospective agencies will be required to fulfil following Criteria for Empanelment as Contractor.

- a) The Firm / Contractor shall be registered with Government / Semi Government organization like CPWD/State PWD/MES/Railways/MSEDCL, Semi Govt. Organisations and other Autonomous bodies under Government of India as contractor. (**For Category `A' and `B' only).**
- b) The Firm / Contractor shall be registered with Income Tax and Service Tax Department as per Govt. rules & regulations.
- c) The Firm/ Contractor should have average annual turnover (gross) for the last three years of Rs. 9,00,000/- (Rs. - e) The financial soundness shall be judged on the basis of the bankers certificate or the working capital certificate, as the case may be issued by the Bankers of the contractor. Such certificate shall be issued by a scheduled bank and shall be submitted, in original in a bank sealed cover, addressed to Director, NIPER, Mohali.
- f) For Electrical and Mechanical Works Category. The applicant must hold valid Electrical/ Mechanical contractor licence. Its staff should hold minimum ITI trade and certificate in the respective cadre and adequate experience in operation/repair/maintenance/renovation of HT & LT electrical installations consisting of transformer/ UPS systems/ pump motors and starters of multi-storey offices and residential buildings.
- g) <u>For Pest Control and Anti Termite Treatment, Fumigation work.</u> The contractor should hold valid licence from civil department for holding/storing/ setting insecticides in the premises.
- h)"The requirements of Electrical and Mechanical contractors are mentioned in Clause 1.2 (f) above. Any contractor meeting these requirements should form the basis of selection for Electrical and Mechanical works. However, a contractor who wishes to get empanelled for Civil works is also allowed to get empanelled for Electrical, Mechanical and any other specialist works provided he meets the mandatory requirements in the concerned field".
- i) If a contractor wants to apply for more than one category, separate application should be submitted for each category.

1.3 ISSUE OF APPLICATION FORM:

TERMS AND CONDITIONS

2.0 TERMS AND CONDITIONS

- 2.1 Application form for empanelment shall be submitted in a sealed envelope super scribing thereon 'Application for Empanelment as Civil/Electrical/Mechanical Contractor under category 'A'/'B'/'C'.
- 2.2 The application shall be submitted strictly in the prescribed format along with supporting documents.
- 2.3 The application shall be signed by the authorized person/s on behalf of the applicant organization by enclosing an Authority Letter / Power of Attorney.
- 2.4 If the space in the application is insufficient for furnishing full details, the applicant may give the details on a separate sheet.
- 2.5 Application containing false and / or incomplete information is liable for rejection.
- 2.6 If any information or details furnished by applicants are found to be false at any time in future, the empanelment of such applicant will be cancelled immediately.
- 2.7 The Bidder should sign each page of the application.
- 2.8 Overwriting should be avoided. Correction, if any, should be made by neatly rounding off, initialling, dating and rewriting.
- 2.9 NIPER, S.A.S Nagar may approach / visit the contractor's clients to verify contractor's general reputation / competence.
- 2.10 Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. With regard to the completed works, copies of the work order and completion certificate shall be submitted.
- 2.11 The applicant has to submit the Client's Certificate as per Annexure-8 (for Category `A'only), from at least two of their clients mentioned in the list of work executed.
- 2.12 Decision of the Director, NIPER, S.A.S Nagar in selection of contractors will be final and binding and no further correspondence will be entertained. Contractors empanelled will be informed by post.
- 2.13 The enlistment of a contractor at NIPER, S.A.S Nagar shall only entitle him to be considered for issue of tender paper. It shall not confer any right on him either to be necessarily issued the tender papers or for award of work.
- 2.14 Generally, the routine works at NIPER, S.A.S Nagar will be awarded by calling competitive quotations /tenders from the empanelled contractors.
- 2.15 NIPER, S.A.S Nagar reserves the right to call open tenders in which agencies not empanelled in this process but meeting the qualification criteria for the tender can participate. For such tenders, the Empanelled contractors under this process meeting the stipulated criteria of tender can also participate.
- 2.16 The empanelment shall be valid for a period of 2 years.
- 2.17 The contractors who would be empanelled are required to deposit Rs. 5,000/- for Class `A' category, Rs. 3,000/- for Class `B' category and Rs. 1,000/- for Class `C' category as security. Such deposit does not carry any interest and it will remain with the Institute till the validity period of the empanelment.
- 2.18 The empanelled firm is required to keep updated the Institute about the change of address, change of the Management etc. from time to time.

- 2.19 The applicant should ensure that the application is delivered at the given address within prescribed date and time as mentioned in the advertisement.
- 2.20 <u>Near Relatives Working in NIPER, Mohali</u>. Contractors whose near relatives are working in NIPER will not be considered for empanelment. For this purpose a near relative shall mean wife, husband, parents, grandparents, children, grandchildren, brothers, sisters, uncles, aunts, cousins and their corresponding in-laws as per **CPWD guidelines**. Necessary certificate to this effect be furnished as per <u>Annexure-9</u>.
- 2.21 Director, NIPER on recommendation of Engineer-in-Charge may remove the name of the firms from the empanelled list if the contracting firm,

- 2.21 No individual, or a firm having such individual as one of the partners, who is a dismissed government servant, or diverted to lower class, or having business banned or suspended by any government department in the past or convicted by a court of law shall be entitled for enlistment. However, cases where disciplinary action was taken against a contractor for a specified period and such penalty period is already over, his case for enlistment/revalidation can be considered.
- 2.22 A contractor is not permitted to have enlistment in more than one name.
