SCREENING CRITERIA ADOPTED:

A. Essential qualification & experience:

Strictly as per the advertisement. Duration of Ph. D. excluded, while reckoning 10 years teaching/research/industrial experience.

B. Area of expertise & Experience:

Relevant to the post as per the advertisement and NIPER requirement as under:

“Isolation, purification and characterization of natural products from medicinal plants and microbial sources using sophisticated techniques such as HPLC, LC-MS, GC-MS and NMR including 2-D NMR techniques/in-vitro and in-vivo biological evaluation of natural products/pharmacognostical identification of medicinal plants/development of Nutraceutical and Phytopharmaceutical products/AYUSH formulations/AYUSH pharmaceuticals of herbal drugs/AYUSH drugs/Dravyaguna and Rasasashtra.”

C. Research:

Minimum 10 research papers excluding review articles in the relevant area as advertised, as first author/corresponding author in reputed journal having impact factor 3.0 and above.

Weightage:

- i. One Patent is considered to be equivalent to one research paper as first author/corresponding author with impact factor 3.0 and above.
- ii. One research paper as first author/corresponding author in relevant research area in a Journal of high impact factor of 10 and above is given double weightage i.e. considered equal to two papers

D. Age-limit:

As advertised i.e. maximum 50 years as on closing date of application.
