In continuation of Recruitment Cell Notice No. 545 dated 07.02.2024 uploaded on Institute's website, the Skill Test of shortlisted candidates for the post Scientist Gr. II/Technical Supervisor Gr. II against Advt. No. 11/2022 will be conducted at NIPER, SAS Nagar on **22.03.2025 (Saturday)** as per given schedule:

Note: Skill Test will include practical aspects/experiments followed by interaction and will be based upon the experience criteria advertised for the post and area of option exercised for Written Test. Working place of Skill Test will be informed to the shortlisted candidates at the time of documents verification.

Instructions for the candidates appearing for Skill Test:

- All shortlisted candidates for Skill Test are being communicated through e-mail only at the e-mail address provided by the candidates in their application form. In case, any candidate has not received the e-mail, may request the same through e-mail at recruitmentcell@niper.ac.in.
- Candidate must report at the venue at **09:00 am on 22.03.2025. No candidate will be allowed after 09:15 am, in any circumstances.**
- Candidates must bring any of the document, in original, listed below as Identity proof:
 - Aadhaar Card
 - Indian Passport
 - Driving Licence
 - Voter Id Card
 - Identity card issued by Central/State Government
- In the absence of valid Identity proof, in original, such candidates shall not be allowed to appear in Skill Test, in any circumstances.
- The candidature of shortlisted candidates is on **PROVISIONAL** basis subject to verification of documents attached from the originals at the time of interview. Therefore, shortlisted candidates have to produce all original documents in support of his/her candidature viz. proof of date of birth, all educational certificates, experience certificates, valid category certificate, if applicable, NOC & vigilance clearance certificate in

respect of the serving candidates in Government/ Semi-Government organizations/ Autonomous Bodies/ PSUs at the time of documents verification. **In absence of the same, such candidates shall not be allowed to appear in Skill Test in any circumstances.**

6. One post is reserved for EWS category. Therefore, shortlisted candidate under EWS category is required to produce latest EWS certificate, in original, issued by the appropriate authority, valid up to 31.03.2025 at the time of document verification. **In absence of the same, such candidate will not be considered under EWS category and will be treated as General category candidate. Under this situation the Skill Test will be subject to shortlisted under UR category.**
7. Shortlisted candidates under SC category are required to produce valid category certificate, in original. **In the absence of the same, such candidate shall not be allowed to appear in Skill Test.**
8. Candidates appearing for Skill Test are required to make their own arrangement for stay and no TA will be allowed to them for appearing in skill test.
9. No books, notebooks, written notes, mobile phones, calculators and other electronic gadgets will be allowed during Skill Test.
10. **Skill Test will only be qualifying in nature. Final selection will be based upon the merit of Written Test conducted on 12.09.2024, subject to qualified in Skill Test.**
