TECHNICAL SPECIFICATION OF ATOMIC FORCE MICROSCOPY (AFM) WITH NANOINDENTATION FACILITY

1. Instrument Resolution

- The instrument should achieve atomic, lattice resolution in AC mode and contact mode imaging.
- Large scan-range scanner with up to (XY) $90-100\mu m \times 90-100\mu m$ in closed loop to allow large survey scan.
- Ability to zoom-in to get high resolution images at a region of interest.

2. Instrument Geometry

- Tip/Sample Scanning Geometry.
- Single rigid frame housing cantilever holder and the optical lever assembly (laser, optics, and detector).
- Capable to handle large (>80mm petridishes, microscope slides etc.) and small samples (mica sheets, etc.) sizes 1 mm to 100mm (dia) and 10mm thick.
- Lateral motorized movement of at least 20mm and motorized vertical movement of at least 10mm, to cover the entire sample range.
- Must include multi-sample holders and tilting stages
- The AFM system must allow software control and automated cantilever approach using the motorized Z stage.

3. Operating Modes

The microscope should be capable of the following scanning modes:

- Contact Mode
- Tapping/Non-Contact Mode
- User friendly full auto-mode to operate system in both air and liquid environment. Setpoint, Gain adjustments should be automated in this mode and should work for all types of samples hard to viscoelastic.
- Force Curve Mode
- Force Mapping Mode (Force Volume) with user selectable ramp rates 1 100Hz or higher.
- Force Modulation
- Nanoindentation mode: Cantilever based nanoindentation function with following key features
 - \circ Indentation force range available should be 1–100 μN with a resolution of less than 0.5 μN . Larger forces up to about 300 μN should be possible with suitable cantilevers.
 - The system should be able to measure hardness up to 3 GPa.

- Particle Analysis to highlight all indents with a certain depth (minimum 5 nm; maximum 2μm) and then selecting the indent of interest.
- Analysis software must be able to measure and provide key statistical parameters such as exact projected area and depth of indentation of each indent
- Nanoindentation should create indents of symmetrical nature by applying variable vertical force within specified range.
- Fluid imaging: The system should be capable of providing high resolution imaging in liquid environment either by tuning the cantilever resonance frequency through by photo thermal, or by imaging at off-resonance frequency by driving the z scanner in sinusoid fashion. Imaging should be done at typical tapping mode imaging speeds (<2 min per image).
- Lateral Force Mode (LFM)
- Electric Force Microscopy (EFM)
- Magnetic Force Microscopy (MFM)
- Kelvin Probe Force Microscopy (KPFM)
- High resolution mode for imaging delicate soft samples in both air & liquid environment while maintaining resolution & clarity.

4. Optical Lever Arm: Light Source and Photodetector

- The instrument optical lever arm should employ a low coherence light source (a super luminescent diode).
- The instrument should use suitable SLD or laser for the optical lever arm.
- High speed, low noise 4-quadrant photodiode detector; choice between red laser and near infrared SLD; laser on/off through software.

5. System Scanner

- Full piezo scanner for XYZ scan control. Voice coil systems are not accepted.
- System should include a closed-loop XY scanner with a range of 90-100 μm
- XY position noise < 0.15 nm in imaging bandwidth (closed loop).
- System should include a closed loop Z scanner with a range of >10 μm
- Z noise <35pm in imaging bandwidth
- For sample scanning systems noise data must be provided with 80mm Petri dish sample with 75% water level during measurement; to simulate real life imaging conditions.
- All noise data should be reported in RMS. Other non-standard formats are not accepted.

6. System Optics

Sample view should be through top View illumination and built-in Hi-res with camera with 10 X objective located in the head. At least 5MP camera. Field of view should be switchable between 720 and 240 microns.

7. Controller and Electronics

- FPGA based controller. Should employ 24-bit digital-to-analog converters (DACs). 32 bit preferable.
- Highspeed ADC and DAC to operate at \geq 50MHz.
- Thermal tunes of the cantilever extending up to 2 MHz.
- The system should provide auto-configuration of external hardware and accessories without the need for parameter files.
- The AFM controller should come with a high-performance processing unit within builtin lock-in amplifier. (2 or more Independent channels digital lock-in)

8. Software

- The AFM system should have separate software for data analysis and measurement.
- Able to perform multi-tasking with Windows based data acquisition, or equivalent and imaging processing programs at the same time.
- The data acquisition software must have built-in macros, which can be easily loaded and applied for repeating operations, such as moving the XY or the Z stage to a specific location or resetting the operation. Users can edit existing macros or create new ones as needed.
- The data acquisition system must be capable of recording individual image sizes of > 4K pixels.
- The software must be available free of cost for all users or Minimum 10 licences must be provided for users.

10. Computer/UPS

- Latest branded PC with windows 10 operating system, 1 TB hard disk, 8 GB RAM, dual 23 inch monitor and licensed software for the operation of the instrument.
- Software must be a single package for all modes and attachments with no need for additional software.
- Software package must include both image acquisition and data processing software in one package with no need for different programs operation.
- ½ hour online backup UPS must be present.

11. Power Supply

The system should be compatible with the Indian power supply e.g., 90-240 V AC, 70 W, 50/60 Hz.

12. Instrument Isolation

• The system must include active vibration table suitable for the system performance and specifications.

• Suitable vibration isolation and acoustic enclosure and appropriate temperature stabilization to be included to limit system drift <200pm/min.

13. Warranty:

Warranty for 2 year should be provided.

14. Accessories

- 100 AFM probes
 - o 8 boxes of tapping mode cantilevers, each containing 10 probes each
 - o 2 boxes of contact mode cantilevers, each containing 10 probes each
 - o 2 boxes of special liquid imaging cantilevers, each containing 10 probes each
- Standard samples for calibrating spatial resolution and calibrating EDS

15. Pre-installation requirements

Pre-installation such as room size, tolerable limit of EM field and vibration (mechanical), required power rating, utility requirements are to be stated clearly, and to be verified/surveyed by the supplier at the installation site UPS to support AFM instrument.

16. Training and support

- All necessary accessories need to attain full functionality such as connecting lines, fittings, wires reference /standard sample for calibration adhesive tape UV chamber for cleaning cantilevers and its storage etc. shall be provided
- Machine should be installed at NIPER-S.A.S. Nagar campus.
- Vendor should provide four times training on operation and application of the equipment on request of user during the initial three year (two basic and two advance training).

17. Optional upgrade

The system should be capable of upgradation to anyone/more of the following upgradation options,

- AFM-Raman Spectroscopy
- AFM-Infrared Spectroscopy
- AFM-Scanning Thermal Microscopy
- AFM-Contact Resonance Imaging
- AFM-Scanning Tunneling Microscopy

Optional upgrades will not be taken into account for technical qualification.

NOTICE INVITING e-TENDERS

- 1. The Bidders shall have to submit their Bids online in Electronic Format Digital Signatures. For participation in the e-tendering process, the Bidders need to register themselves at http:// tenderwizard.com/NIPER and get user ID and password. Class 3 Digital Signature Certificate (DSC) is mandatory to participate in the e-tendering process. (Helpdesk No. for registration 09257209340 & 08054628821).
- 2. E-Tender processing fee shall be payable to M/s ITI Limited through their e-gateway by credit/ debit card, internet banking facility and which is non refundable.
- 3. No tender will be accepted in physical form and in case it has been submitted in Physical it shall be rejected without any communication to the sender.

4. Preparation of Bids:

- (a) Technical bid should be consisting of all technical details alongwith commercial terms and conditions and The tenderer shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs.3,00,000./- (Rupees Three lacs only) which refundable though e-payment (Internet Payment Gateway (Debit & Credit , Net banking & National Electronic Funds Transfer) only . It is further required that the E-receipt/proof of deposit of EMD attached with technical bid and e_tendering mode with other relevant documents. In case of non receipt of earnest money in tender, the tender will be straightway rejected. The MSE's and the firm registered with NSIC may be exempted for deposit EMD.
- (b) Financial bid indicating item-wise price for the items mentioned in the technical bid. The offer/bid should be submitted in two bid systems (i.e.) Technical bid and Financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid in the given format i.e BoQ_XXXX. The Technical bid and the Financial bid should be submitted Online.

5. Submission of tender:

The tender has to be submitted on-line before the due date. The offers received after the due date and time will not be considered. No manual bids will be accepted and considered.

6. Bidding:

- a). Items of indigenous nature or quoted in INR, more than one authorized representative may participate in the same tender and submit their bids on behalf of their OEM/Principal/Manufacturer if the OEM permits more than one authorized bidder in such case as per their policy.
- b). In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer subject to meeting all other condition such as local content etc make in India.
- c) Bid are invited from the Class –I and Class II category of bidders (Refer Annexure E for category of Class supplier) for procurement of Equipment as per specification given in this tender documents. Purchase preference shall be given Class –I category of Bidders as by Govt of India Guidelines revised from time to time.
- d). The letter of authority should be on the letterhead of the manufacturer and should be signed by a person competent and having the power of attorney to bind the manufacturer. The same should be included by the bidder in its techno-commercial unpriced bid.

All offers other than those from the Principal/OEM should be supported by an authority letter

from the manufacturer authorizing the supplier to tender on their behalf. In case of manufacturer a certificate or a copy thereof to the effect that the bidder is a manufacturer of the equipment must be accompanied with the technical bid prepared as per 'Annexure - D'.

7. Opening of Bids:

The online bid will be opened by a committee duly constituted for this purpose. Online bids (complete in all respect) received will be opened as mentioned in the "Schedule". Bid received without documents will be rejected straight way. The technical bid will be opened online first and it will be examined by a technical committee (as per specification and requirement). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification.

8. Price Bid:

Price bid should be submitted in given BOQ_XXXX.xls format online. The price should be quoted in net per unit (after breakup) and must include all packing and delivery charges. Price quoted should be in Indian Rupees, free delivery at NIPER Mohali at site

(DDP/FOR).

Further, depending on the nature of the goods, there may be cost elements towards installation and commissioning, operator's training, and so on. Normally, it may be included in the equipment cost but if it is quoted separately, the same will be added in the item price for the determination of ranking of the bidders. The offer/bid should be exclusive of all taxes and duties, which will be paid by the purchaser as applicable. However, the percentage of taxes & duties shall be clearly indicated. Necessary certificate will be issued on demand in respect of GST and Custom duty. The Buyer/PFC will have the right to award contracts to Bidders being different for lowest in particular For ranking of offers, price of complete scope of supply as detailed in technical specifications, the procuring authority/Purchaser may decide as follows for comparison of

- (i) All items of the bid which are mandatorily required to meet the tendered specifications of the item/system
- (ii) If a bidder has put certain items/modules which are required to meet the tendered specifications in the 'optional' part of the bid, then such optional items shall also be included for the purpose of price Comparison .
- (iii) On the other hand, if a bidder has inadvertently included any item/module in its main price bid which is not required as per tender specifications, then the price of such item/module shall be excluded from the price comparison provided that the price for the said item/module is clearly reflected separately in the bid (iv) Anything asked as 'optional' in our specification is not to be included for overall comparison

Non-conformities between Figures and words: Sometimes, non-conformities/errors are also observed in responsive tenders between the quoted prices in figures and in words. This situation normally does not arise in case of e-Procurement/Etender . This should be taken care of in the manner indicated below:

- (i) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price will be corrected.
- (ii) If there is an error in a total corresponding to the addition or subtraction of sub-totals, the

sub-totals shall prevail and the total shall be corrected; (iii) If there is a discrepancy between words and figures, the amount in words will prevail for calculation of price.

- **9. Taxes:** Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi, road permits, etc.,incurred until delivery of the contracted Goods to the Purchaser. However, GST etc, in respect of the transaction between the Purchaser and the Supplier shall be payable extra, if so stipulated in the order. For research purpose(s) ONLY, 5% GST will be applicable with concessional GST Certificate.
- 10. NIPER Mohali is exempted from paying custom duty under notification No.51/96 (partially or full) and necessary "Custom Duty Exemption Certificate" can be issued after providing following information and Custom Duty Exemption Certificate will be issued to the shipment in the name of the Institute, (no certificate will be issued to third party): The procured product should be used for teaching, scientific and research work only.
- a) Shipping details i.e. Master Airway Bill No. and House Airway No. (if exists)
- b) Forwarder details i.e. Name, Contact No., etc. NIPER Mohali is partially exempted from paying GST and necessary GST Exemption Certificate will be provided for which following information are required.
- b) Quotation with details of Basic Price, Rate, Tax & Amount on which ED is applicable
- c) Supply Order Copy thereof
- d) Proforma-Invoice Copy.

11. Rates Comparison:

Bidders are requested to send their rates on FOR, NIPER Mohali. in Indian rupees.

12. Spares:

The spare parts/wear & tear consumables, if any, required for trouble free operation of equipment to be quoted separately giving the full nomenclature, rate, quantity and shelf life of each item.

13. Indigenous items:

The items which can/are to be provided indigenously may be listed separately.

14. Parts of Equipments:

Where the equipment is composed of several subunits/components, the rate should be quoted for each subunit/component. The Institute reserves the right to increase or decrease the number of subunits/components and number of equipment according to its requirements. The rates in ambiguous terms will render the quotation liable to rejection. The words "Not quoting" should be clearly written against any item of equipment for which the tenderer is not quoting.

15. Payment Terms:

Payment will be made to the supplier through following modes.

a). Indigenous goods:

- i)NEFT/Cheque/Demand Draft : 90% payment will be made within 30 days from the date of receipt of material at NIPER Mohali and balance 10% after successful installation of the equipment and on the submission of performance bank guarantee valid for warranty period + 3 months or
- ii) NEFT/Cheque/Demand Draft : 100% payment will be made within 30 days from the date of receipt of material at NIPER Mohali and successful installation of the equipment.

16. Acceptance of Terms & Conditions:

Bidders must confirm the acceptance of all the terms and conditions of this NIT. Any non-acceptance or deviations from the terms and conditions must be clearly mentioned. However, tenderers must note carefully that any conditional offer or any deviation from the terms and conditions of this NIT. may render the tender liable for rejection.

17. Service Manual/Curcuit Diagram

It is specifically required that the bidders will supply all the operating & service manuals and circuit diagrams alongwith the equipment.

18. Power Supply:

The equipment should be quoted only for 220 volts and 50Hz electricity supply. The extra requirement of line voltage, current rating etc. and the optimum climate and environment required for the equipment must be stated precisely. Voltage stabilizers/isolation transformers/CVT/UPS etc., as may be required shall be listed separately. The full technical specifications and literature in respect of the voltage stabilizer etc., must be furnished.

19. Guarantee/Warranty:

Duly signed and stamped certificate of at least 1 years comprehensive onsite warranty as per **Annexure-B** should be attached with the technical bid. Successful firm will be required to agree for payment of penalty for exceeding permissible downtime during Guarantee / Warranty period.

In addition to quoting for the equipment, the tenderers are also requested to quote separately, the charges and terms and conditions of SERVICE CONTRACT FOR A PERIOD OF FIVE YEARS, for maintaining the equipment at this institute after the expiry of the period of guarantee/warranty. The terms and conditions of the Service Contract are given in **Annexure** 'C'. It may be noted that the service contract charges may also be considered along with the cost of equipment while evaluating the quotations. Price List of Spares parts must be quoted In case of any loss or damage done to the property / existing infrastructure of the Institute attributable to the personnel of the contractor, the full damages will be recovered from the Agency / Contractor and decision of the Competent Authority of institute in this regard will be final and binding on the contractor

20. Country of origin:

i) Country of origin of the quoted item should be mentioned in the offer in case of imported item.

As per Ministry of Finance, Deptt. of Expenditure, Public Procurement Division Order (Public Procurement No.1) issued from file No.6/18/2019-PPD dated 23rd July, 2020 regarding Restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017, it is directed that any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or works (including turnkey projects) only if the bidder is registered with the Competent Authority i.e. the Deptt. for Promotion of Industry and Internal Trade (DPIIT). - **22. Training:** If required, should be included in your offer without any extra cost
- 23. Banker's details: Name and address of the banker of your company should be mentioned
- **24. Reference of supply:** Name and contact details of the premier educational Institutes where the quoted equipment has been installed in India should be attached as per **Annexure-G**. Copies of at least two purchase orders may be attached(If possible). NIPER Mohali reserves the right to inspect the equipment for its actual performance in any of the listed Institute
- 25. NO WITHDRAWAL AFTER SUBMISSION OF BID OR MODIFY THE TERMS & CONDITIONS after acceptance of tender. In case Bidder fails to observe and comply with the stipulation made herein or back out after quoting the rate, the aforesaid amount of EMD/Performance Guarantee will be forfeited by NIPER-SAS Nagar, Mohali . Besides this, the bidder will also be liable to be debarred/backlisted from participating in the tendering process of NIPER SAS Nagar Mohali in future and/or suitable penalty will be levied.

25.Arbitration

- 1. In the event of failure to carry out the contractual obligations, with in the stipulated period or extended period and determination of the contract for any reason. Violation of the warranties etc. the NIPER Mohali shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.
- 2. The provision of the Arbitration and conciliation Act, 1996 or as at relevant time and of rules framed there under and any statutory modifications thereof shall be deemed to apply and be incorporated in this agreement.
- 3. Upon every or any such reference, the cost of any incidentals to the reference and award(s) respectively shall be at the reasonable discretion of the Arbitrators or in the event of their not agreeing, of the Umpire appointed the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall be direct by whom and in what manner the same shall be borne and paid.
- 4. Panel of arbitrators will be provided by NIPER Mohali out of which the bidder will have to select one.

- 5. The bidder shall have no objection if the officer who has dealt with the case at any stage is nominated as an arbitrator. Further, that one of the arbitrator's shall be Accounts Expert.
- 6. In case of vacancy being caused due to resignation, death or incapacity of the arbitrator's to function as such, the same shall be provided in the aforesaid manner and the new arbitrator's shall proceed from the stage at which vacancy is caused.
- **26. Jurisdiction:** The court of Mohali alone will have the jurisdiction to try any matter, dispute or difference between the parties arising out of his tender/contract. It is specifically agreed that no Court outside and other than Mohali court shall have jurisdiction in this matter.
- **27. Force Majeure**: Any failure of omission or commission to carry out the provision of this contract by the supplier shall not give rise to any claim by one party, one against the other, if such failure of omission or commission arises from an act of God; which shall include all acts of natural calamities such as fire, flood, earthquake, hurricane or may pestilence or from civil strike, compliance with any statute and/or regulations of the Government, lockouts and strikes, riots embargoes or from any political or other reason beyond the supplier's control including war (whether declared or not) civil war or stage of insurrection, provided that notice of the occurrence of any event by either party to the other shall be given within two weeks from the date of occurrence of such an event which could be attributed to Force Majeure conditions.
- **28 Risk & Cost** In the event of failure to carry out the obligations, within the stipulated period or extended and determination of the contract for any reason, violation of warranties etc. The NIPER Mohali shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.

- i) I/We certify that the guarantee/warranty shall be starting from the date of satisfactory installation, commissioning and handing over of the equipment and of works conducted therewith covered under the Supply order in working Condition. During the guarantee/warranty period I/We shall provide "after sale service" and the replacement of any part(s) of the equipment or rectification of defects of work of the equipment will be free of cost. The replacement of the parts shall be arranged by us, at our own cost and responsibility. We undertake that the above guarantee/ warranty shall begin only from the date of installation, commissioning and handing over the equipment in working order. The benefit of change in dates of the guarantee/warranty period shall be in the interest of the user/your Institute.
- ii) During the warranty period, we shall provide at least three preventive maintenance visits & all breakdown services without any charges.

TERMS AND CONDITIONS OF THE SERVICE CONTRACT

- i) During the service contract period, the firm shall provide at least THREE preventive maintenance visits and attend to all emergent and break-down calls per year.
- ii) Rate of AMC/CMC will be quoted for the period after completion of warranty period and order for AMC/CMC be placed after completion of warranty (if required)
- iii) The service contract charges must be quoted separately for each year strictly.
- iv) The service contract charges should be quoted only for services and travel cost etc. and should not include the cost of any replacement parts/components which shall be arranged by the Institute at its own cost. However, a price list of all spares must be provided to the Institute.
- v) The removed/un serviced spare parts shall be the property of NIPER, Mohali and shall be handed over to Indenter by the service provider along with service report.
- vi) In each block of 365 days during the entire service contract period the firm will be responsible to maintain the equipment in good working condition for a period of 328 days (i.e. 90% uptime). The time taken by the Institute in providing to the firm the spare parts shall not count towards the downtime. All the complaints will be attended by the firm within 5 days of the dispatch of the complaint to their office. In case there is delay of more than 5 days in attending to a complaint then the number of days in excess of the permissible response time shall be counted in the downtime. The above said response time of 5 days for attending to a complaint will not be counted in the downtime. In case total downtime exceeds the permissible limit as defined above, the service contract shall be extended by the period in excess of the permissible downtime subject to limit of 30 days in a block of 365 days. However, for the period of the downtime in excess of 30 days in block of 365 days, a fine equivalent of double the daily service contract charges shall be recovered from the firm.
