PROJECT VACANCY – PROJECT TECHNICAL SUPPORT-III UNDER PROJECT NO. GP-487

Applications are invited from eligible Indian nationals for temporary position of **Project Technical Support-III** under a project entitled “**Aptamer based diagnostic test for vulvovaginal candidiasis**” (GP-487) sponsored by Indian Council of Medical Research (ICMR) vide Project No. DDR/STICALL/13/9/2023 under supervision of Prof. Tarun Kumar Sharma, Department of Medical Devices, NIPER-SAS Nagar. The position is purely on temporary basis initially for a period of 1 (one) year, extendable on yearly basis on the satisfactory performance of the candidate for a maximum period of 02 (two) years subject to availability of funds and is co-terminus with the duration of the project.

Other requirements of the position are as under:

1. No. of Position: 01 (One)

2. Essential Qualification:

First class Post Graduate (PG) degree (including the integrated PG degrees) such as M. Sc. (Biotechnology/Microbiology/Medical Biotechnology)/M. Tech. (Biotechnology) or any allied area of science.

3. Desirable Qualification:

Candidates having experience in the Development of diagnostic assays, aptamers, antibodies and venomics will be given preference.

4. Age limit: Not more than 35 years (age relaxation for SC/ST/OBC/PwBD is as per GoI rules. The candidates are required to attach valid proof for claiming relaxation as per the guidelines prescribed by the Government of India from time to time).

5. Fellowship: Rs. 28,000/-p.m. + HRA, as admissible.

6. The engagement is full time and purely on temporary basis for all intent and purposes initially for a period of 01 year and extendable on yearly basis on the satisfactory performance of the candidate for a maximum period of 02 (two) years subject to availability of funds and is co-terminus with the duration of the project.
