**PROJECT VACANCY - TECHNICAL SUPPORT-III UNDER PROJECT NO. GP-486
(Advt. No. 10/2025, dated 13.06.2025)**

Applications are invited from eligible Indian nationals for one temporary position of **Technical Support-III** under a project entitled “**Development of a metabolite-based point-of-care test for diagnosis of bacterial vaginosis in Indian women**” (GP-486) sponsored by Indian Council of Medical Research (ICMR), under supervision of Prof. Tarun Kumar Sharma, Department of Medical Devices, NIPER-SAS Nagar. The position is purely on temporary basis initially for a period of 1 (one) year, extendable on yearly basis on the satisfactory performance of the candidate for a maximum period of 02 (two) years and is co-terminus with the duration of the project.

Other requirements of the position are as under:

1. Essential Qualification:

Post Graduate (PG) degree such as M. Sc. (Biotechnology/Microbiology/Medical Biotechnology) OR M. Tech. (Biotechnology).

2. Desirable Qualification:

Candidates having experience of Protein Biochemistry, Molecular Biology, Diagnostics Assay Development and Biosensing will be given preference.

3. Age limit: Not more than 35 years (age relaxation for SC/ST/OBC/PwBD is as per GoI rules. The candidates are required to attach valid proof for claiming relaxation as per the guidelines prescribed by the Government of India from time to time).

4. Fellowship: Rs. 28,000/-p.m. + HRA, as admissible.

5. The engagement is full time and purely temporary for all intent and purposes initially for a period of 01 year and extendable on yearly basis on the satisfactory performance of the candidate for a maximum period of 02 (two) years and is co-terminus with the duration of the project.

6. The interviews will be held **on-line** and only shortlisted candidates will be called for interview. **Interview call letters will be sent through e-mail only.** Candidate should keep their email id & mobile no. provided in the application form active. - 12.** Candidates are required to attach the valid proof of deposit of the prescribed application fee, wherever applicable, with the application form. The application form received without valid proof of deposit of the prescribed application fee will be summarily rejected and no representation/request shall be entertained in this regard.
- 13.** Candidates with incomplete application or without relevant supporting enclosures (i.e. self-attested copies of degree / certificates / marks sheets / experience certificate/ reprint of important publications, without photographs, signatures and prescribed fee) will not be interviewed.
- 14.** The candidature will be considered as invalid, ab-initio, in case he/she does not fulfil the eligibility criteria. Candidate should satisfy himself/herself regarding the possession of required qualification, age, experience, etc., as stipulated above, as on the last date of receipt of application, before appearing in on-line interview, if shortlisted.
